MEETING MINUTES

Groundwater Sustainability Agency for the Eastern Management Area in the Santa Ynez River Groundwater Basin March 28, 2024

A special meeting of the Groundwater Sustainability Agency (GSA) for the Eastern Management Area (EMA) in the Santa Ynez River Groundwater Basin was held on Thursday, March 28, 2024, at 6:30 p.m. at Santa Ynez Community Services District Community Room, 1070 Faraday Street, Santa Ynez, California.

EMA GSA Alternate Committee Member Steve Jordan attended the meeting via teleconference from 46250 Fairway Drive, Indian Wells, CA 92210. This remote participation location was properly noticed on the agenda and the agenda was posted at the remote location, in compliance with Gov. Code Section 54950 et seq. No members of the public joined Director Jordan at the location.



EMA MINIMUM THRESHOLDS

- PASO ROBLES FORMATION
 - Measured in 14 wells (one well dry for many years)
 - MT is 15 feet below Spring 2018 water levels
- CAREAGA SAND FORMATION
 - Measured in 9 wells (5 measured by SBCWA)
 - MT is 12 feet below Spring 2018 water levels

Undesirable results: Groundwater levels remain below Minimum Thresholds after two consecutive years of average or above-average precipitation in 50 percent of representative wells.




